I understand that the rules and regulations of the UTSDC Design Fair and Conference and the student code of conduct are designed for the safety and protection of participants, and hereby undertake that my child will abide by these rules and regulations and code of conduct.

- This document applies for the UTSDC Design Fair and Conference from May 13 - 16, 2010 and when relevant, other UTSDC events
- We will be running on strict timelines for all activities. Participants are responsible for arriving and departing at the appointed times
- Smoking is not permitted in any University buildings, including New College Residence
- Possession and/or consumption of alcohol is forbidden throughout the duration of the Design Fair and Conference. No participant, regardless of age, is permitted to consume alcoholic beverages. Alcohol offenses will be considered a major offence and therefore carry a zero tolerance policy
- Possession and/or consumption of illegal drugs is considered a criminal offence. It will be considered a major offence and therefore carry a zero tolerance policy
- Every participant has the right to privacy over his or her own personal belongings
- Participants should lock their room doors when leaving and have their keys at all times. If a key is lost, the lock will be changed at the participant's expense of approximately \$115
- Participants will be required to be on their floor by 10:00 pm and in their respective rooms by 11:00 pm unless a supervised activity goes on longer
- All participants are required to be present for head counts that will occur at 9:00 am (breakfast), 12:00 pm (lunch), 5:00 pm (before dinner) and 10:00 pm (before bed)
- Participants will not be permitted to go beyond the perimeter of New College, the New College lawn or the Bahen Centre for Information Technology without the expressed permission of the supervising don. No participants under the age of 16 will be permitted to go beyond the set boundary without don supervision
- Participants are responsible for keeping all common areas (hallways, common rooms) clean after use. Participants are also responsible for keeping his/her room clean
- Any damage to or removal of furnishings is prohibited. Participants will be required to pay for any damaged property
- Male/female participants are not permitted together in Residence rooms. Participants may work together in common rooms and other designated areas
- Participants are responsible for getting to their meals on time, as determined in the forthcoming itinerary. Participants who missed meals will not be reimbursed
- Every participant has the right to respect from other participants and will be treated as such.
